EMERGENCY.

Whereas, invitations were extended by this City to certain qualified financial institutions for the deposit of Interim Funds belonging to the City, and

Whereas, the acceptance of these invitations to bid by certain duly qualified financial institutions will enable the City to contract with all eligible institutions for Interim Funds, and gives the City an advantage for better interest rates on investments, and

Whereas, bank rates on Interim Deposits change daily and it is to the advantage of the City to be able to select the bank giving the highest and best interest rate at the time Interim Funds become available, and

Whereas, the City will not be restricted to one bank and one interest rate, and

Whereas, the ability to enter into contracts and make deposits with all eligible banks will enable the City to realize more favorable services from the banking community.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

**SECTION 1:** This Council authorizes and directs the Mayor to enter into Interim Deposit contracts and to direct the Director of Finance to make Interim Funds with any or all eligible banks as recognized and defined by the City Charter and Ordinances and the Ohio Revised Code for a period of five (5) years beginning August 23, 2021 and ending August 22, 2026.

**SECTION 2.** This Council authorizes and directs the Mayor to enter into Interim Deposit contracts with any or all eligible banks and to direct the Finance Director to make Interim Deposits with any of the following institutions as funds may become available:

Keybank National Association  
PNC Bank  
US Bank

Huntington National Bank  
STAR Ohio

Such contracts and deposits shall be made by the Director of Finance in the best interests of the city.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:
