AN ORDINANCE INCREASING THE UNIFORM ALLOWANCE FOR THE GARFIELD HEIGHTS AUXILIARY POLICE FORCE FROM TWO HUNDRED AND FIFTY DOLLARS TO FIVE HUNDRED DOLLARS IN ACCORDANCE WITH SECTION 128.04(a) OF THE CITY OF GARFIELD HEIGHTS CODIFIED ORDINANCES.

WHEREAS, The City of Garfield Heights Auxiliary Police Force is a great asset to the City and has served the community well, and

WHEREAS, the current uniform allowance for the Auxiliary Police Force is two hundred and fifty dollars (\$250.00) per year and has remained the same since 2006, and

WHEREAS, to reflect the increased cost of maintaining proper uniforms for the Auxiliary Police Force, the current uniform allowance should be increased from two hundred and fifty dollars (\$250.00) to five hundred dollars (\$500.00).

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Garfield Heights, Ohio, that:

SECTION 1. The current uniform allowance shall be increased from two hundred and fifty dollars (\$250.00) to five hundred dollars (\$500.00) annually in accordance with Section 128.04(a) of the Codified Ordinances of the City of Garfield Heights.

SECTION 2. The Finance Director is hereby authorized and directed to issue her vouchers of the City, for the purpose set forth in Section 1 hereof, said vouchers to be charged to the appropriate fund.

SECTION 3. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OR HIS DESIGNEE TO PURCHASE FIFTEEN (15) MOTOROLA APX6000 PORTABLE RADIOS FROM MOTOROLA SOLUTIONS TO BE USED BY THE GARFIELD HEIGHTS POLICE DEPARTMENT

WHEREAS, The City of Garfield Heights would like to purchase fifteen (15) Motorola APX6000 portable radios from Motorola Solutions, and

WHEREAS, the Garfield Heights Police Department utilizes approximately sixty (60) radios; the radios currently in use are outdated and will no longer be able to be updated in the near future, and

WHEREAS, it is the City's intention to replace approximately fifteen radios each year until all have been replaced, and

SECTION 1. The Mayor or his designee is hereby authorized and directed to purchase fifteen (15) Motorola APX6000 portable radios from Motorola Solutions, and in a total amount not to exceed \$65,000.00 (quotation attached hereto as Exhibit A and incorporated as if fully written within).

SECTION 2. The Finance Director is hereby authorized and directed to issue her vouchers of the City for the purpose set forth in Section 1 hereof, said amount to be charged to the appropriate Fund.




AN EMERGENCY ORDINANCE PLACING A TEMPORARY MORATORIUM, NOT TO EXCEED SIX (6) MONTHS, ON CARWASH ESTABLISHMENTS WITHIN THE CITY OF GARFIELD HEIGHTS

WHEREAS, Pursuant to the Constitution of the State of Ohio and the Ohio Revised Code, municipalities have the power to enact planning and zoning laws that are for the health, safety, and welfare, comfort and peace of the citizens of the municipality, including restricting areas used for businesses and trades, and

WHEREAS, this Council desires to issue a moratorium, for a temporary period of time, not to exceed six (6) months from the date of passage of this Ordinance, while it undertakes a review and/or study of the Ordinances of the City of Garfield Heights, including the zoning, building and business regulation sections of the Garfield Heights Codified Ordinances, and

WHEREAS, this Council will be able to enact reasonable regulations to protect the health, safety, welfare, peace, and comfort for the citizens of the City of Garfield Heights more effectively if a moratorium is in place.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

SECTION 1. Council hereby approves a temporary moratorium, not to exceed six (6) months, of the granting of any permits allowing carwash establishments within the City of Garfield Heights.

SECTION 2. Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
