AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO DO ALL THINGS NECESSARY TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S), FOR THE MULTI-STREET RECONSTRUCTION & WATERLINE REPLACEMENT – PHASE 7 – PROJECT, INCLUDING, BUT NOT LIMITED TO EXECUTING ANY AND ALL APPLICATIONS, AGREEMENTS AND /OR CONTRACTS AS MAY BE REQUIRED BY THE OPWC IN ORDER TO SECURE THE LOAN FUNDS REQUESTED, PER THE APPLICATION AS PREPARED BY CITY ENGINEER DAVID KROCK.

WHEREAS, In Ordinance 56-2021, the City Council authorized the Mayor to apply for grant funding thru the Ohio Public Works Commission, (OPWC) for the Multi-street Reconstruction & Waterline Replacement – Phase 7 Project, and

WHEREAS, the following 5 street locations listed in the Project Fact Sheet attached hereto; will have waterlines replaced, streets reconstructed and storm & sanitary sewer repair as needed, and

WHEREAS, the waterline replacement, storm and sanitary sewer repair, and street reconstruction will improve the health and safety of the residents and businesses in the area, and

WHEREAS, this reconstruction project did not receive the grant funding through the Ohio Public Works Commission State Capital Improvement and/or Local Transportation Improvement Grant Program(s), and

WHEREAS, the City of Garfield Heights wishes to secure loan funding for this project to the Ohio Public Works Commission for a period of 30 years and 0% interest, and

WHEREAS, Cleveland Water Department's share of the project would be 60% (\$1,404,000), and the City of Garfield Heights share of the project would be made for 40% (\$936,000), and

WHEREAS, most of the City of Garfield Heights share of the project will be funded thru the Ohio Public Works Commission Loan Application (\$702,000).

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. The Mayor is hereby authorized and directed to do all things necessary to participate in the Ohio Public Works Commission State Capital Improvement and/or Local Transportation Improvement Program(s), for the Multi-Street Reconstruction & Waterline Replacement – Phase 7 Project, including, but not limited to executing any and all applications, agreements and/or contracts as may be required by the OPWC, in order to secure the funds requested, as prepared by City Engineer, David Krock.

SECTION 2. The Finance Director hereby authorized and directed to issue her vouchers for the City, to be charged to the appropriate fund for the purposes set forth in Section 1 hereof.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore, this Ordinance shall be in full force and effect immediately upon the adoption by Council and approval by the Mayor; otherwise from and after the earliest period allowed by law.

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 50-2021 TO UPDATE THE SALARIES OF THE POLICE DEPARTMENT FOR 2022 IN ACCORDANCE WITH SECTION 41 OF THE GARFIELD HEIGHTS CHARTER

WHEREAS, this Ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department, and

WHEREAS, Section 41 of the Garfield Heights Charter provides that the rate of compensation for members of the police and fire division of the Department of Public Safety shall be no less than the average that is paid to the members of the police and fire divisions in suburban cities with a population of ten thousand (10,000) or more whose boundary lines are contiguous to the City of Cleveland, and

WHEREAS, the Collective Bargaining Agreement between the City of Garfield Heights and the Ohio Police Benevolent Association and the Fraternal Order of Police provides that the following rates shall be paid beginning January 1, 2022.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Garfield Heights, Ohio, that:

SECTION 1. Ordinance No. 50-2021 is amended to read as follows:

Paragraph 1.

(A) There shall be one (1) Chief of the Police Department who shall receive the sum of One Hundred Twenty-One Thousand, Three Hundred, and Two dollars (\$121,302.00) per annum and payable every two (2) weeks.

(B) There shall be no more than two (2) Captains of the Police Department who shall receive the sum of One Hundred and Seven Thousand, Five Hundred and Nine Dollars (\$107,509.00) per annum, payable every two (2) weeks.

(C) There shall be no more than six (6) Lieutenants of the Police Department who shall each receive the sum of Ninety-six Thousand, Four Hundred and Three Dollars (\$96,403.00) per annum, payable every two (2) weeks.

(C) There shall be no more than six (6) Sergeants of the Police Department who shall each receive the sum of Eighty-Six Thousand, Two Hundred, Fifty-Six Dollars (\$86,256.00) per annum, payable every two (2) weeks.

(D) There shall be no more than thirty-nine (39) Patrolmen of the Police Department whose salaries shall be as follows:

(1) First Class Patrolmen with two (2) years or more of service shall each receive the sum of Seventy-Five Thousand, Four Hundred and Ninety-Six Dollars (\$75,496.00) per annum, payable every two (2) weeks.

(2) Second Class Patrolmen with more than one (1) year but less than two (2) years of service shall each receive the sum of Sixty-Five Thousand, Two Hundred and Zero Dollars (\$65,200.00) per annum, payable every two (2) weeks.

(3) Third Class Patrolmen with one year or less of service shall each receive the sum of Fifty-Eight Thousand, One Hundred and Five Dollars (\$58,105.00) per annum, payable every two (2) weeks.

SECTION 2. Those provisions contained in Ordinance No. 50-2021 are inconsistent with the provisions in this Ordinance, are hereby repealed from and after the effective date of this Ordinance.

SECTION 3. The Finance Director is hereby authorized and directed to issue her vouchers of the City for the purpose set forth in Section 1. hereof, said vouchers to be charged to the appropriate fund.

SECTION 4. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore this Ordinance shall be in full force and effective immediately upon the adoption by Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 51-2021 TO REFLECT INCREASED SALARIES OF THE FIRE DEPARTMENT FOR 2022 IN ACCORDANCE WITH SECTION 41 OF THE GARFIELD HEIGHTS CHARTER

WHEREAS, this Ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department, and

WHEREAS, Section 41 of the Garfield Heights Charter provides that the rate of compensation for members of the police and fire division of the Department of Public Safety shall be no less than the average that is paid to the members of the police and fire divisions in suburban cities with a population of ten thousand (10,000) or more whose boundary lines are contiguous to the City of Cleveland, and

WHEREAS, the Collective Bargaining Agreement between the City of Garfield Heights and the Local 340 of International Assn. of Firefighters, AFL-CIO provides that the new rates shall be paid beginning January 1, 2022.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Garfield Heights, Ohio, that:

SECTION 1. Ordinance No. 51-2021 is amended to read as follows:

Paragraph 1.

(A) There shall be one (1) First Class Fireman known as Chief of the Fire Department who shall receive the sum of One Hundred Sixteen Thousand, Seven Hundred, Twenty-Three Dollars (\$116,723.00) per annum, payable every two (2) weeks.

(B) There shall be no more than four (4) Third Class Firemen who shall be known as Captains of the Fire Department who shall each receive the sum of Ninety-Four Thousand, Six Hundred, Twenty-Four Dollars (\$94,624.00) per annum, payable every two (2) weeks.

(C) There shall be no more than seven (7) Fourth Class Firemen known as Lieutenants of the Fire Department who shall each receive the sum of Eighty-Five Thousand, Two Hundred, Thirty-Six Dollars (\$85,236.00) per annum, payable every two (2) weeks.

(D) There shall be no more than thirty-two (32) Fifth Class Firemen whose salaries shall be as follows:

(1) Fifth Class Fireman, First Grade with two (2) years or more of service and reached the rank of Fifth Class Fireman, First Grade prior to January 1, 2018 shall each receive the sum of Seventy-Four Thousand, Nine Hundred, Twenty-Four Dollars (\$74,924.00) per annum, payable every two (2) weeks.

(2) Fifth Class Fireman, First Grade with two (2) years or more of service and reached the rank of Fifth Class Fireman, First Grade on or after January 1, 2018 shall each receive the sum of Seventy-Four Thousand, Seven Hundred, Sixty-Eight Dollars (\$74,768.00) per annum, payable every two (2) weeks.

(3) Fifth Class Fireman, Second Grade with more than one (1) year but less than two (2) years of service shall each receive the sum of Sixty-Three Thousand, Seven Hundred, Ninety-Six Dollars (\$63,796.00) per annum, payable every two (2) weeks.

(4) Fifth Class Fireman, Third Grade with one year or less of service shall each receive the sum of Fifty-Four Thousand, Five Hundred, Eighty-Six Dollars (\$54,586.00) per annum, payable every two (2) weeks.

SECTION 2. Those provisions contained in Ordinance No. 51-2021 which are inconsistent with the provisions in this Ordinance, are hereby repealed from and after the effective date of this Ordinance.

SECTION 3. The Finance Director is hereby authorized and directed to issue her vouchers of the City for the purpose set forth in Section 1. hereof, said vouchers to be charged to the appropriate fund.

SECTION 4. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore this Ordinance shall be in full force and effective immediately upon the adoption by Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
