AN ORDINANCE AUTHORIZING THE DISPOSAL OF MUNICIPALLY OWNED PROPERTY WHICH HAS BEEN DETERMINED TO BE NO LONGER NEEDED FOR MUNICIPAL PURPOSES PURSUANT TO SECTION 129.02 OF THE CODIFIED ORDINANCES OF THE CITY OF GARFIELD HEIGHTS

WHEREAS, Pursuant to Section 129.02 of the Codified Ordinances of the City of Garfield Heights, the Chief of Police has determined that certain municipally owned properties are no longer needed for municipal uses or have become unsuitable for such uses; and

WHEREAS, the Mayor of the City of Garfield Heights, also pursuant to Section 129.02 of the Codified Ordinances, has approved this determination in writing, and

WHEREAS, the City of Garfield Heights intends to donate said property to the City of Maple Heights.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. Pursuant to Section 129.02 of the Codified Ordinances of the City of Garfield Heights, this Council hereby approves the disposal, by donating the same to the City of Maple Heights, of the following municipally owned properties which have been determined by the Chief of Police to be no longer needed for municipal uses or have become unsuitable for such uses, and such determination being approved by the Mayor in writing:

1. 45 Body Cameras, Model: BC 4 (See attached exhibit)
2. 4 Camera Data Transfer Docks, Model: BC4-Dock-10
3. 50 Alligator Camera Mounting Clips
4. 44 Magnetic Camera Mounts

SECTION 2. In addition to the aforesaid equipment being donated to the City of Maple Heights, 14 Non-Operating Provision Body Cameras to will be disposed of as listed in the attached exhibit.

SECTION 3. The Chief of Police is hereby authorized and directed to transfer said items identified herein to the City of Maple Heights for disposal in accordance with Section 129.02 of the Codified Ordinances.

SECTION 4. This Ordinance shall be in full force and effect from and after the earliest period allowed by law.

AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING
THE MAYOR TO APPLY FOR AND ACCEPT THE OHIO
ENVIRONMENTAL PROTECTION AGENCY H2OHIO RIVERS
INITIATIVE CHLORIDE REDUCTION GRANT

WHEREAS, chloride from deicers entering surface waters from roadways and stormwater runoff is an increasing water quality concern in Ohio; and

WHEREAS, the City of Garfield Heights ("City") is eligible to apply for funding from the Ohio Environmental Protection Agency ("Ohio EPA") to reduce chloride; and

WHEREAS, the City intends to apply for the H2Ohio Rivers Initiative Chloride Reduction Grant; and

WHEREAS, the Garfield Heights Service Department has identified the Road Deicing Equipment/Facility Improvements eligible in the grant application; and

WHEREAS, funding is provided through reimbursement grants up to \$75,000 for actual equipment purchased and installed or for the cost to improve or construct facilities; and

WHEREAS, if selected, the City of will enter into an agreement with the State of Ohio and will have 12 months to purchase and install equipment and to make facility upgrades.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Garfield Heights, Cuyahoga County, Ohio, that:

SECTION 1. The Mayor be and he is hereby authorized and directed to take whatever steps may be necessary to make an application with and enter into an agreement with the Ohio EPA.

SECTION 2. The Finance Director be and is hereby authorized and directed to issue her vouchers for the City, to be charged to the appropriate fund for the purposes set forth in Section 1. hereof.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.

AN EMERGENCY RESOLUTION AUTHORIZING THE
MAYOR OR HIS DESIGNEE TO APPLY FOR A 2024
COMMUNITY PLANNING GRANT TO IMPLEMENT
RECOMMENDATIONS OF THE CITY OF GARFIELD
HEIGHTS MASTER PLAN

WHEREAS, The City of Garfield Heights ("City") applied for and was awarded a grant for professional planning and technical services provided by the Cuyahoga County Planning Commission ("County"); and

WHEREAS, the County and the City have worked together to develop a comprehensive, useable and actionable Master Plan; and

WHEREAS, the Garfield Heights Master Plan provides the City with Focus Area Recommendations; and

WHEREAS, the City acknowledges that the professional planning services offered by the County provide value to the community; and

WHEREAS, Corridor Studies are eligible activities in the 2024 Community Planning Grant Program; and

WHEREAS, the E. 131st neighborhood and the Turney Road (North of I-480) corridor have been identified as Focus Areas in the Garfield Heights Master Plan; and

WHEREAS, the City would like to begin to implement the recommendations in the Master Plan with further assistance from the County by conducting Corridor Studies in the E. 131st neighborhood and the Turney Road (North of I-480) corridor.

NOW, THEREFORE, BE IT RESOLVED by the Council of Garfield Heights, Cuyahoga County, Ohio, that:

SECTION 1. The City is authorized to apply for a 2024 Community Planning grant from the Cuyahoga County Planning Commission.

SECTION 2. Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare and shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
