AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR, OR HIS DESIGNEE, TO ENTER INTO AN ADDENDUM WITH ANAGO CLEANING SYSTEMS FOR THE PURPOSE OF EXPANDING THE CLEANING SERVICES PROVIDED TO THE GARFIELD HEIGHTS CIVIC CENTER

WHEREAS, in Ordinance 67-2023, the Garfield Heights City Council authorized the City to enter into an agreement with Anago Cleaning Systems for the purpose of providing cleaning services for the Garfield Heights Police Department and the Civic Center; and

WHEREAS, the parties have proposed an addendum which expands cleaning services in the Civic Center to include the recently updated Economic Development Department; and

WHEREAS, the additional cost of cleaning services provided to the Civic Center will be \$1,029.00.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. The Mayor, or his Designee, is hereby authorized and directed to enter into an addendum with Anago Cleaning Systems (attached hereto at Exhibit A and included as if fully written within) for the purpose of expanding the cleaning services provided to the Garfield Heights Civic Center at an additional cost not to exceed \$1,100.00.

SECTION 2. The Finance Director is hereby authorized and directed to issue her vouchers of the City for the purposes stated in Section 1. hereof, said vouchers to be charged to the appropriate fund.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore, this Ordinance shall be in full force and effect immediately upon the adoption by Council and approval by the Mayor; otherwise from and after the earliest period allowed by law.

AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OR HIS DESIGNEE TO PURCHASE TWO (2) X-TREME VAC LEAF PICK-UP MACHINES THROUGH BEST EQUIPMENT COMPANY UNDER OHIO REVISED CODE SECTION 125.04(C)

WHEREAS, in Ordinance 95-2023, the Garfield Heights City Council authorized the City to pursue funding for the purchase of two (2) leaf pick-up machines; and

WHEREAS, upon securing the funding through the Northeast Ohio Regional Sewer District Community Cost Share, the City identified two X-TREME VAC leaf pick-up machines available for purchase through Best Equipment Co; and

WHEREAS, the total cost of the equipment will be \$234,225.60; and

WHEREAS, per Ohio Revised Code Section 125.04(C) governmental agencies may purchase equipment/services without bidding so long as the equipment/service has been purchased for less than or equal to the cost of the state contract; and

WHEREAS, these items are available for purchase without bidding through the City's membership with Sourcewell (formerly National Joint Powers Alliance) under Contract #031121-ODB.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Garfield Heights, Ohio, that:

SECTION 1. The Mayor or his designee is hereby authorized and directed to purchase two (2) X-TREME VAC leaf pick-up machines at a cost not to exceed \$235,000.00 (quotation for both attached hereto as Exhibit A and incorporated as if fully written within).

SECTION 2. The Finance Director will determine the options for the purchase of the equipment contained herein and said amount will be charged to the appropriate Fund.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore this Ordinance shall be in full force and effective immediately upon the adoption by Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
