AN ORDINANCE AUTHORIZING ALL ACTIONS NECESSARY TO ESTABLISH AN OPT-IN NATURAL GAS PROGRAM IN THE CITY OF GARFIELD HEIGHTS PURSUANT TO SECTION 4929.27(A)(1), OHIO REVISED CODE, JOINTLY THROUGH NOPEC AS A NOPEC MEMBER, AND DECLARING AN EMERGENCY

WHEREAS, the City of Garfield Heights, Ohio ("City"), has previously enacted Ordinance 01-2002, establishing an "opt-out" natural gas aggregation program pursuant to Section 4929.26, Ohio Revised Code, for its residents, businesses, and other consumers located within the City jointly through NOPEC as a NOPEC member; and

WHEREAS, to expand the natural gas supply options available to residents, businesses and other consumers within the City of Garfield Heights, the City wishes to establish an "opt-in" natural gas aggregation program pursuant to R.C. 4929.27(A)(1) (the "Opt-In Natural Gas Aggregation Program") for its residents, businesses and other consumers located within the City and, for that purpose, to act jointly with any other city, village, city, municipal corporation, county or other political subdivision of the State of Ohio, as permitted by law; and

WHEREAS, the City wishes to conduct the Opt-In Natural Gas Aggregation Program jointly through NOPEC as a NOPEC member.


NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. This Council hereby approves and authorizes the establishment of an Opt-In Natural Gas Aggregation Program in the City of Garfield Heights jointly through NOPEC as a NOPEC member and adopts this Ordinance pursuant to the authority contained in R.C. 4929.27(A)(1).

SECTION 2. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore, this Ordinance shall be in full force and effect immediately upon the adoption by Council and approval by the Mayor; otherwise from and after the earliest period allowed by law.

AN ORDINANCE APPROVING THE PLAN OF OPERATION AND GOVERNANCE FOR THE NOPEC OPT-IN GAS AGGREGATION PROGRAM IN THE CITY OF GARFIELD HEIGHTS FOR THE PURPOSE OF JOINTLY ESTABLISHING AND IMPLEMENTING AN OPT-IN GAS AGGREGATION PROGRAM AS A NOPEC MEMBER, AND DECLARING AN EMERGENCY

WHEREAS, this Council previously enacted Ordinance 01-2002 authorizing the City of Garfield Heights (the "City") to establish an "opt-out" Gas Aggregation Program pursuant to Section 4929.26, Ohio Revised Code (the "Opt-Out Gas Aggregation Program"), for the eligible residents, businesses and other gas consumers in the City, and for that purpose, to act jointly with any other municipal corporation, city, county or other political subdivision of the State of Ohio, as permitted by law; and

WHEREAS, this Council previously enacted legislation authorizing the City to join the Northeast Ohio Public Energy Council (NOPEC), to execute a Natural Gas Program Agreement and adopt the NOPEC Gas Aggregation Program Plan of Operation and Governance, so that the City would be able to act jointly with other member political subdivisions and thereby maximize the potential benefits of gas deregulation through group purchasing efforts; and

WHEREAS, this Council has enacted legislation establishing an "opt-in" natural gas aggregation program pursuant to R.C. 4929.27(A)(1), Ohio Revised Code, (the "Opt-In Natural Gas Aggregation Program") for the eligible residents, business and other consumers located within the City, and to conduct the Opt-In Natural Gas Aggregation Program jointly through NOPEC as a NOPEC member; and

WHEREAS, on behalf of this Council pursuant to R.C. 4929.27(B), two (2) public hearings have been scheduled to take place on Tuesday, October 15, 2024, regarding the Plan of Operation and Governance for the NOPEC Opt-In Natural Gas Aggregation Program.



AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR AND ACCEPT THE AMERICAN RESCUE FUNDS ACT COMMUNITY GRANT FUND MADE AVAILABLE BY CUYAHOGA COUNTY, AND DECLARING AN EMERGENCY

WHEREAS, the City of Garfield Heights ("City") is requesting funding from the Cuyahoga County ("County") American Rescue Plan ("ARPA") Community Grant Fund for the Garfield Heights/St. John Lutheran Church Basketball Court Renovation project in Cuyahoga County, Ohio; and

WHEREAS, pursuant to Cuyahoga County Council Approval, the County will award an amount not to exceed \$37,000 to the City to support the project; and

WHEREAS, the City previously accepted ARPA Community Grant funding to support parks improvements at Debelak and Forestdale Parks; and

WHEREAS, when ARPA funds are awarded, the County and the City will enter into an agreement that will govern their respective obligations with respect to the award for the project and the reimbursement of funds; and

WHEREAS, City's Parks and Recreation Department will oversee the St. John Lutheran Church Basketball Court Renovation in collaboration with church staff.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. The Mayor or his designee is hereby authorized and directed to do all things necessary to apply for and accept Cuyahoga County ARPA funding made available in the county Community Grant Fund for the purpose of collaborating with St. John Lutheran Church to renovate its gymnasium for the purpose of allowing the public to participate in a city-run basketball program as well as for public use.

SECTION 2. The Finance Director is hereby authorized and directed to issue her vouchers of the City for the purposes stated in Section 1. hereof.

TO INCREASE THE RATES FOR EMERGENCY MEDICAL SERVICES
IN THE CITY OF GARFIELD HEIGHTS

WHEREAS, the City of Garfield Heights ("City") has been approached by its third-party billing company, Great Lakes Billing Associates, Inc. and advised that the City needs to increase the rates it is currently charging insurance companies and non-residents for Emergency Medical Services ("EMS"); and

WHEREAS, municipalities traditionally review and increase rates every four years to correspond to the increasing cost of the services being provided; the City of Garfield Heights last increased its rates in 2019 when this Council passed Ordinance 11-2019; and

WHEREAS, currently, the City charges \$600.00 for Basic Life Support calls, \$750.00 for Advanced Life Support I calls, \$850.00 for Advanced Life Support II calls, and \$14.00 per mile travelled; and

WHEREAS, Great Lakes Billing Associates, Inc. has recommended the City increase the rates to \$650.00 for Basic Life Support calls, \$800.00 for Advanced Life Support I calls, \$1100.00 for Advanced Life Support II calls, and \$16.50 per mile travelled; and

WHEREAS, accordingly, the City would like to increase its rates to correspond to the amount recommended by Great Lakes Billing Associates, Inc.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Garfield Heights, Ohio, that:

SECTION 1. The Mayor or his designee is hereby authorized and directed to increase the rates for Emergency Medical Services in accordance with the aforementioned rate schedule.

SECTION 2. 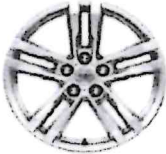

A RESOLUTION RECOGNIZING THE MONTH OF OCTOBER AS
BREAST CANCER AWARENESS MONTH IN THE CITY OF
GARFIELD HEIGHTS

WHEREAS, breast cancer is one of the most common cancers affecting women in the United States, with approximately 1 in 8 women expected to receive a breast cancer diagnosis in their lifetime, and men also being susceptible, though at a much lower rate, with 1 in 1,000 men diagnosed annually; and

WHEREAS, early detection through mammograms and other screening methods significantly increases survival rates, but many individuals face barriers to accessing these critical healthcare services, particularly those in underserved communities; and


