

ORDINANCE NO.: 83-2021

AN ORDINANCE AUTHORIZING THE SALE AND DISPOSAL OF MUNICIPALLY OWNED PROPERTY WHICH HAS BEEN DETERMINED TO BE NO LONGER NEEDED FOR MUNICIPAL PURPOSES PURSUANT TO SECTION 129.02 OF THE CODIFIED ORDINANCES OF THE CITY OF GARFIELD HEIGHTS.

WHEREAS, pursuant to Section 129.02 of the Codified Ordinances of the City of Garfield Heights, various departmental Directors of the City have determined that certain municipally owned properties are no longer needed for municipal uses or have become unsuitable for such uses; and

WHEREAS, the Mayor of the City of Garfield Heights, also pursuant to Section 129.02 of the Codified Ordinances, has approved this determination in writing; and

WHEREAS, the City of Garfield Heights intends to utilize the GovDeals Online Auction Site for the disposal of the various items identified herein as authorized pursuant to Ordinance 81-2010.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. Pursuant to Section 129.02 of the Codified Ordinances of the City of Garfield Heights, this Council hereby approves the sale of the following municipally owned properties which have been determined by the various Directors to be no longer needed for municipal uses or have become unsuitable for such uses, and such determination being approved by the Mayor in writing:

SECTION 2. AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OR HIS DESIGNEE TO ENTER INTO A TWO-YEAR MOTOR VEHICLE REGISTRATION AUDIT AGREEMENT, FOR THE YEARS ENDING DECEMBER 31, 2021 AND 2022, WITH DALENE M. PRIDE, GOVERNMENTAL AFFAIRS CONSULTANT, TO CONDUCT AUDITS OF CERTAIN OHIO BUREAU OF MOTOR VEHICLES RECORDS, PER THE ATTACHED AGREEMENT

WHEREAS, Dalene M. Pride has performed the Bureau of Motor Vehicle audits identified herein for the City of Garfield Heights for the past 25 years, and

WHEREAS, the BMV audits identified herein have been instrumental in the City obtaining its' correct share of vehicle registration funds from the State, and

WHEREAS, due to the ongoing, continuing effort of performing these audits, the costs are not expected to increase significantly.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. The Mayor, or his designee, is hereby authorized and directed to enter into a two-year Motor Vehicle Registration Audit agreement, for the years ending December 31, 2021 and 2022, with Dalene M. Pride, Governmental Affairs Consultant, to conduct audits of certain Ohio Bureau of Motor Vehicles records, per the attached agreement.

SECTION 2. The Finance Director is hereby authorized and directed to issue her vouchers of the City for the purposes stated in Section 1. hereof, said vouchers to be charged to the appropriate fund.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the immediate preservation and protection of the public peace, health, safety, and general welfare of the inhabitants of the City of Garfield Heights and shall take effect and be in full force immediately upon its adoption by this Council and approval by the Mayor, otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

AGREEMENT
BUREAU OF MOTOR VEHICLES TAXING DISTRICT AUDITS

This Agreement authorizes Dalene M. Pride, an independent governmental affairs consultant, to conduct an audit of certain Ohio Bureau of Motor Vehicles records for, and on behalf of, Garfield Heights, Cuyahoga County, Ohio. The audits will include the following:

The Bureau of Motor Vehicles registration records of various municipalities will be audited and all registrations of Garfield Hts. residents and businesses that have been incorrectly allocated will be recorded on the prescribed forms. A copy of all incorrect registrations will be transmitted to the appropriate political subdivision for review and challenge within the thirty-day period allowed by the Bureau of Motor Vehicles.


After the thirty-day challenge period has expired, a copy of all incorrect registrations will be forwarded to the Bureau of Motor Vehicles where the appropriate corrections and adjustments will be made.

Dalene M. Pride will conduct the audits and will deliver copies of the "Taxing District/Township Audit Findings Report" forms to the appropriate taxing districts and to the Bureau of Motor Vehicles.

Garfield Hts., Ohio, will pay Dalene M. Pride the sum of Three Dollars and Fifty Cents (\$3.50) for each incorrect non-IRP license registration and \$10.00 for each IRP truck registration forwarded to the Bureau of Motor Vehicles for correction and adjustment.

Garfield Hts., Ohio, wishes to have the months of January through December, 2021 and 2022* audited pursuant to this Agreement.
