WHEREAS, Garfield Heights Ordinance 40-2019 authorized the Mayor to apply for funding of the Midwest Neighborhood Storm/Sanitary Sewer System Reconstruction project through the Northeast Ohio Regional Sewer District Program(s); and

WHEREAS, the City of Garfield Heights was awarded funding for this Phase 4 project, and

WHEREAS, the purpose of this five-phase project is to eliminate residential basement flooding and property damage, reduce flows to the District's infrastructure for treatment of removing storm water from the currently combined sewer system and improve water quality in area waterways, and reduce and eliminate property damage to both public infrastructure and private property, and

WHEREAS, Ordinance 28-2020 authorized David Krock, City Engineer and OHM Advisors to take the necessary steps to begin the Midwest Neighborhood Storm/Sanitary Sewer System Reconstruction Project – Phase 4, and

WHEREAS, additional monies are needed to perform project performance verification to document how a Member Community Infrastructure Program project is performing.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GARFIELD HEIGHTS, OHIO, THAT:

SECTION 1. The Mayor or his designee is authorized and directed to sign the OHM Advisors Proposal attached hereto as Exhibit "A", for Project Performance Verification of the Midwest Neighborhood Project – Phase 4, which may be funded through the Northeast Ohio Regional Sewer District.

SECTION 2. The Finance Director is authorized and directed to issue her vouchers of the City for the purposes stated in Section 1. hereof, to OHM Advisors in an amount not to exceed \$46,000.00 dollars, for the project performance verification for Midwest Neighborhood Project - Phase 4, and said vouchers to be charged to the appropriate fund.

SECTION 3. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore, this Ordinance shall be in full force and effect immediately upon the adoption by Council and approval by the Mayor; otherwise from and after the earliest period allowed by law.



Project Understanding

The Northeast Ohio Regional Sewer District (NEORS, or “the District”) requires its member communities to perform project performance verification to document how a Member Community Infrastructure Program (MCIP) project is performing. The District requires that the Garfield Heights Midwest Neighborhood Phase 4 MCIP sewer separation project perform and report on the following project performance verification activities:

- Post-construction flow monitoring
- Pre- and post-construction rainfall-derived inflow and infiltration (RDII) evaluation*
- Dry weather water quality sampling

(*Note: Pre-construction flow monitoring data was previously collected by OHM Advisors for pre-construction RDII analysis.)

Post-construction flow monitoring and RDII analysis quantifies and evaluates private property inflow and infiltration (I/I) contributions to the new sanitary sewer. Sampling at the discharge of the new storm sewer during dry weather verifies no domestic sewage is contributing to flow in the pipe.

OHM proposes the following work be performed as part of this project in order to meet the District’s 2019 MCIP requirements:

- Perform post-construction flow monitoring at the location where the pre-construction flow data was collected
- Calculate pre- and post-construction RDII for the project area
- Conduct end-of-pipe water quality sampling for *E. coli* on three separate days at three different times during dry weather
- Prepare a technical submittal

Scope of Services

Task #1 Background Data Collection and Review (\$6,000)

Task 1 includes collecting available data from the City and the District necessary to complete the proposed tasks. It is expected that the following data will be made available to perform the work:

- As-builts from the City providing the length, diameter, material and invert elevation of the constructed sewer separation project
- Pre-construction flow monitoring performed by the District
- Rainfall data from a District-owned rain gauge sufficient for the project’s needs

Task #2 Post-Construction Flow Monitoring (\$12,000)

For MCIP sewer separation projects, the District requires pre- and post-construction sewer flow monitoring to document the hydraulic performance and flow characteristics in the MCIP project area. OHM Advisors performed the pre-construction flow monitoring for this project in October 2019. The objective of Task 2 is to measure and record the flow in the sanitary sewer as a result of the sewer separation projects. To accomplish this, one flow meter will be installed on the new sanitary sewer, downstream of the MCIP project area. The meter location is shown in Figure 1 (attached).

To meet the District’s MCIP flow monitoring requirements, post-construction flow metering will be conducted for a three-month duration, or until three storms that meet either of the following criteria are captured:

- Rain event meets or exceeds a depth of 0.5 inches AND an intensity of 0.25 inches/hour
- 24-hour rainfall is greater than 0.75 inches

Specific work efforts of the flow monitoring task include the following:

- Coordinate with the District to prepare for post-construction flow monitoring
- Flow meter pre-installation site investigation to determine installation feasibility and prepare for installation
- Provide for traffic control and safety during site visits
- Install and calibrate one flow meter at the following location: District Manhole ID unknown (located in backyard of 5268 E. 102nd Street)
- Collect and record the following flow data in 5-minute intervals over a continuous monitoring period for a duration up to three months:
 - Depth
 - Velocity
 - Flowrate
- Maintain and service flow meters, including battery replacement
- Perform data downloads (manual data downloads two times per month or telemetry transfer of meter data during monitoring period, if feasible)
- Bi-weekly review of manual download data
- Uninstall meters at conclusion of monitoring period

Task #3 RDII Analysis (\$7,000)

The flow monitoring data collected in Task 2 will be used to perform the RDII analysis. The objective of Task 3 is to quantify the amount of I/I in the sanitary sewer system as a result of the sewer separation project. For MCIP sewer separation projects, the District requires pre- and post-construction RDII analysis that provides, at a minimum, a calculation of the percentage of rainfall that enters the sanitary sewer system for each rain event. The District refers to this percentage as the R-value; the term “R-value” is used interchangeably with “percent I/I” and “capture coefficient.” The R-value will be determined for each storm event recorded during the monitoring period using the H2Ometrics software. Per the Districts request, Phase II post-monitoring data will also be used as Phase III/IV pre-monitoring data for the analysis.

Specific work efforts of the RDII analysis task include the following:

- Import flow monitoring and District rainfall data into H2Ometrics software
- Edit (“scrub”) flow monitoring data using H2Ometrics software
- Calculate RDII for each storm event with rainfall that caused a wet-weather response in the monitored sanitary sewer

Task #4 Post-Construction Dry Weather Water Quality Sampling (\$7,000)

The District requires dry weather water quality sampling for MCIP sewer separation projects. The objective of the sampling is to obtain data that verifies the infrastructure separation. Post-construction performance verification includes collecting and analyzing dry weather flow samples from the storm water pipe at the downstream end of the separated area. Sampling is required on three separate days and at three different times, in order to ensure a representative *E. coli* measurement. OHM has partnered with a local water and wastewater lab to perform *E. coli* lab analysis on collected samples.

Specific work efforts of the dry-weather water quality sampling task include the following:

- Collect three field samples on three separate days at three different times during dry weather at the end of the new storm sewer
- Perform lab analysis for *E. coli*

Task #5 Technical Submittal (\$14,000)

All work included in the tasks above will be summarized and presented in the format of a technical submittal according to District minimum requirements.

The minimum deliverables required as part of the submittal to the District include the following:

- For flow monitoring and RDII evaluation:
 - Site installation forms
 - Rain data in 5-minute intervals
 - Raw and edited flow monitoring data in 5-minute intervals
 - RDII evaluation summary, including supporting tables and figures
 - RDII evaluation conclusions
- For water quality sampling:
 - Field sample collection summary, including supporting tables and figures
 - Sample analysis results
 - Water quality sampling conclusion

AN EMERGENCY ORDINANCE AMENDING SECTION 307.02,
LOCATION AND CAPACITY, OF THE CODIFIED ORDINANCES
OF THE CITY OF GARFIELD HEIGHTS

WHEREAS, Chapter 307, *Vehicle Storage Pounds*, of the Codified Ordinances of the City of Garfield Heights regulates the towing and storage of vehicles for the Garfield Heights Police Department, and

WHEREAS, Chapter 307 states that the City shall contract with at least two agencies located within the City for the purpose of towing and storage of vehicles, and

WHEREAS, currently, only one towing company meets the requirements of Chapter 307, and

WHEREAS, accordingly, the City wishes to amend Section 307.02 to permit the City to contract with towing and storage facilities that are located no further than five (5) miles from the City of Garfield Heights.

NOW, THEREFORE, BE IT ORDAINED by this Council of the City of Garfield Heights, Ohio that:

SECTION 1. Section 307.02 of the Codified Ordinances of the City of Garfield Heights, Ohio, which currently reads:

The City auto storage pounds shall be located ~~in the City~~ in areas zoned commercial use district or lower, pursuant to the provisions of the Zoning Code and its accompanying Map. The repair garages designated by the Safety Director pursuant to the provisions hereinafter set forth shall have sufficient accompanying lot areas to accommodate at least ten cars.

Shall be amended to read as follows:

The City auto storage pounds shall be located **within five (5) miles of the City** in areas zoned commercial use district or lower, pursuant to the provisions of the Zoning Code and its accompanying Map. The repair garages designated by the Safety Director pursuant to the provisions hereinafter set forth shall have sufficient accompanying lot areas to accommodate at least ten cars.

SECTION 2. This Ordinance is declared to be an emergency measure in that the adoption of the Charter created the Division of Purchases and Supplies and it is immediately necessary to make purchases for the conduct of the ordinary affairs of the City, and for the health, welfare, peace, and safety of its residents, and it shall take effect immediately upon its passage and approval by the Mayor.

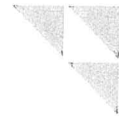

Scope of Services (Specialty Tasks)

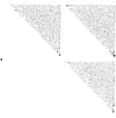
Task #1 Geotechnical Services

- The following services are included in the fee shown:
 - Performance of six (6) test boring locations to 15 feet each or bedrock depth.
 - Standard penetration sampling per current ASTM standards.
 - Water level readings.
 - Identification and evaluation of soil properties.
 - Summary of existing pavement composition and thicknesses.
 - Written report of findings and recommendations including:
 - Soil profile and subsurface conditions.
 - Pavement design recommendation.
 - Constructability cautionary notes.
 - This information will be used for follow-on engineering tasks.

Task #2 Topographic Survey

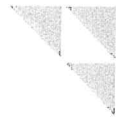
